
## **Higher Education Zone**

The NUS has further developed its tuition fees campaign. This has been a national priority campaign 'Funding our Future', and has seen town takeover events across the country and the Vote for Students campaigns that commits politicians to sign a pledge to not vote for tuition fee increases.

The HE Zone reported back on work carried out on the student experience, assessment & feedback, post-grad study and supporting students in the recession.

I voted to approve the report.

## **Society and Citizenship Zone**



The best way to describe this zone is to compare it to work the Guild carries out on ethical and environmental, community and democratic engagement issues. This makes this zone a special interest for me.

A key element of the zone over the past year has been the development of the Vote for Students campaign. The zone has also campaigned for political rights for students in Burma, HE improvements in Iraq,

sustainable green impacts on campuses and votes for 16.

I voted to approve the report.

## **Union Development Zone**

This Zone focuses on the support that NUS provides for constituent member unions in relation to democratic engagement on our campuses and student activities in particular.

The VPUD reported of the work of the activist academies that were held across the country turning union officers and key individuals into campaigning activists. These are being further developed and a bigger roll-out is expected next year. We also heard about work being done to develop and support key unions in the Arts institutions and further education.

I voted to approve the report.

#### Welfare Zone

This zone incorporates the work our VP Welfare does but with some extra responsibilities for housing and community safety.

We heard about awareness campaigns for student employment rights. Due to the delays in processing student loans, the NUS have been lobbying behind the scenes with vice-chancellors and prominent housing providers asking for leniency with payments.

The zone has also been campaigning to strengthen the tenancy deposit protection scheme.

I voted to approve the report.

## **Trustee Board and NEC**

This report included updates on the work of the Trustee Board and recommendations from the Appointments Panel of external Trustees which I approved.

It also included a more admin/clerical update of the NEC and I liked the table used to show attendance at NEC meetings. *Perhaps it's something that the Guild should adopt for the Officer Group meetings?* 

## **Accounts and Estimates**

I voted to approve the Accounts and Estimates. For the first time in 10 years NUS is reporting a surplus and the finances are in good hands. More money is being spent and devoted to campaigns, not just the priority campaign, but also campaigns for the liberation associations and in Northern Ireland, Scotland and Wales.

However, I felt that there was not enough time for delegates to scrutinise the accounts and the National President only had 10 minutes to present them. I have made this view clear to NUS and I hope next year there will be more time for financial scrutiny.

## **Censures on officers**

Wes Streeting was censured for not doing enough work on the Palestinian conflict. I voted to reject the censure as I thought Wes has spent his time developing NUS' higher education priority campaigns and building a financially stable national union. The censure did not pass.

Bellavia Ribeiro-Addy, Black Students Officer and Daf Adley, LGBT Officer were censured for their behavior during the Durham affiliation referendum. Bell and Daf had sent a letter to Durham Students Union expressing concern and threatening officers for allowing their debating society to host BNP members in a debate. They had also spoken to the Vice-Chancellor at Durham. Their actions on behalf of NUS were awful and they at no time attempted to speak to the students union about their views. This led students to call for an affiliation referendum which voted overwhelmingly for Durham SU to disaffiliate. I voted to censure both Bell and Daf. Bell's censure passed but Daf's fell. Both votes were very close.

## **Final thoughts**

2010 conference was my first experience of Annual Conference and my first experience of Newcastle!! Great city, great nightlife! ☺

I immensely enjoyed the experience even though it was a lot of hard work for delegates. It was interesting to see the politicised nature of the event. Some people think we do factions in the Guild but you don't know what a faction is until you see it at annual conference. Slating in elections is a must and to win you simply must have decent factional support. I don't really know whether that's good or bad on the national level. I certainly don't mind factions and I think they can be good as long as you're open about it. Labour Students and Far-left candidates always put their political views on their manifestos but Organised Independents do not and I think if you're open and honest about your politics then no one can really criticise you. It's important to know what people's values are to a certain extent.

I didn't find it all too overwhelming, the sessions were chaired very well with clear explanations as to what a yes or a no vote meant in each instance so it was very easy to follow. I would encourage this practice to be built into our own Guild Council meetings.
